Rules and Instructions for Submission

The Broadway Subway Project ("BSP") is being delivered by the Government of British Columbia as defined in the British Columbia Interpretation Act (the "Province") through its agent Transportation Investment Corporation ("TI Corp").

How to submit artwork:

- i. Visit our Community Office on Monday or Wednesday to submit in person between the hours of 9am-5pm at 1212 W. Broadway (Broadway and Alder), Vancouver BC; or
- ii. Mail (Artwork Submissions, Suite 500, 575 W. 8th Avenue, Vancouver, B.C., V5Z 0C4, Canada).

Information Required:

- i. Artwork. The artwork or a copy of the artwork on the provided entry template (which may be delivered in person or submitted via mail);
- ii. Agreement to Rules. Confirmation of the agreement to the terms set out in this form (the "Rules") by the artist's parent or legal guardian by including a copy (a digital copy if submitted via e-mail or a physical copy if submitted by mail or in person) of the agreed-to Rules (with the "I agree" box checked and name and email provided where indicated); and
- iii. Personal Information. The first name and age of the artist where indicated on the entry template, and the first name, surname and e-mail of the artist's parent or legal guardian on the agreed-to Rules.

Rules:

Submissions are open to British Columbia residents aged 12 and under. Artwork must be created by a child aged 12 or under (the "Artist") using the entry template provided, and the artwork must be submitted by the Artist's parent or legal guardian above the age of 18. There is no limit on the number of submissions that can be submitted.

Submissions received after June 2, 2023 may not be accepted. Mailed submissions will not be returned to the Artist. The Province is not responsible for artwork or submissions that are lost or damaged, or which are misdirected or otherwise fail to reach the Province.

The artwork must not contain any personal information of the Artist, other than the Artist's first name and age, and must not contain any personal information of any third party. The artwork may be in colour or black and white and must be hand-drawn without the usage of digital assistance.

The Province retains the right to refuse to accept, reproduce or display any submitted artwork, for any reason, including the failure of a parent or legal guardian to agree to these Rules by checking "I agree" and including an agreed-to copy of these Rules together with the submission, and entirely at the Province's discretion.

By submitting the Artist's artwork, you confirm that: (i) you are the parent or legal guardian of the Artist; (ii) you have read and agree with these Rules, including the notices below concerning the collection and disclosure of personal information; (iii) the submission is original artwork created by the Artist for the sole purpose of submission to the Province; (iv) you authorize the participation of the Artist in this contest, including the submission of the Artist's artwork to the Province; (v) the Artist is aware of and has consented to you making the submission and consenting to disclosure of personal information on their behalf; and (vi) you are responsible for the Artist's participation in the submission.

All artwork, including the copyright and all other intellectual property rights in and to the artwork, shall remain the property of the Artist. By submitting artwork, the Artist grants a perpetual, royalty-free, non-exclusive, worldwide license to the Province, its agents (including TI Corp), advisors and contractors (the "Province Parties") to reproduce and display the artwork on websites, social media, BSP materials and other construction materials or surfaces associated with the BSP or at BSP sites. The Artist also agrees that the Province Parties may make reasonable alterations to the artwork in order to

optimize display on websites, social media, BSP materials and other construction materials or surfaces associated with the BSP or at BSP sites. The Artist agrees to waive all "moral rights" that the Artist may have in the submitted artwork, including the right to prevent modification of the artwork, the right to prevent certain uses of the artwork, and the right to have the Artist's name associated with the artwork.

You, on your own behalf and on behalf of the Artist, hereby: (i) release the Province Parties and all directors, officers and employees of each of the Province Parties from any and all liability related to the collection, use and display of the submitted artwork; and (ii) indemnify and hold harmless the Province Parties and all directors, officers and employees of each of the Province Parties from and against all claims, demands, obligations, losses, liabilities, costs, debts and expenses (including reasonable legal fees) in connection with the collection, use and display of the submitted artwork and including any claims or actions based on infringement or violation of third party intellectual property rights and any claims that any of the submitted artwork caused damage to a third party.

If the Artist's artwork is selected for display on construction materials or surfaces at BSP sites, a Province representative may contact you to advise you and/or to obtain further information, and you may be required to sign a separate release form.

Collection of Personal Information:

Your personal information will be collected for the purpose of communicating with you in relation to the submission of the Artist's artwork, and personal information of the Artist will be collected for the purpose of attributing artwork to the Artist, and assessing the breadth of participation across various schools. This information is being collected by the Province and TI Corp under section 26(c) of the British Columbia *Freedom of Information and Protection of Privacy Act*. Disclosure of Personal Information:

Certain personal information of the Artist, namely the Artist's first name and age, will be disclosed to the public by displaying the information together with the artwork online (including at broadwaysubway.ca/learninghub/gallery and/or on social media posts related to the BSP), in BSP materials and/or on construction materials or other surfaces associated with the BSP or at BSP sites. The personal information of the Artist will be disclosed for the purpose of attributing artwork to the Artist, and the personal information will be disclosed to anyone with access to the Internet and anyone who accesses other BSP materials or visits BSP sites.

By checking this box I confirm that I have read and agree to these terms on my behalf and on behalf of the Artist, and unless and until I notify the Province otherwise in writing, I consent on my behalf and on behalf of the Artist to the disclosure of personal information as described above.
